THE BOULDER SHELTER FOR THE HOMELESS PROVIDED SHELTER AND MEALS FOR HOMELESS ADULT MEN AND WOMEN. THE SHELTER SERVED OVER 83,500 MEALS AND PROVIDED 37,000 BEDS FOR 1,000 INDIVIDUALS DURING THE YEAR. TOTAL SERVICE DAYS WERE 46,000, WHICH INCLUDED DAYTIME FACILITIES FOR INDIVIDUALS NOT REQUIREING A BED. THE SHELTER'S TRANSITION PROGRAM GRADUATED 39 RESIDENTS. THE SHELTER PROVIDED 2,997 CASE MANAGEMENT CONTACTS DURING THE YEAR.
